

SWT 2007 Rules & Regulations

Trail Categories

Angler of the Year ** Team of the Year
Mixed Team of the Year, Youth Angler of the Year
Sports Person of the Year
Dooly's High Five Team award
Backwoods Rods High Five Angler award
Overall 1 only, 2 only, 3 only tournaments
Big Fish of the Year
Heavyweight of the Year (one day weight)
Championship Challenge
Approx. \$2,000 cash/prizes given out at each tournament

** To qualify you must fish with at least 3 or more different partners over the course of the season and use the points from at least 3 of those different partners. **Partners must be members of the SWT for points to count**

An individual or team may win only one of the major categories listed: Angler, Team, Mixed Team, Dooly's High five, Backwoods Award

Participants and Eligibility

- Members must enter as individuals
- Each member must possess a valid provincial fishing license. The SWT does not sell licenses.
- Each member must complete and sign an official registration form along with registration fee
- Registration is allowed all through the season right up to last tournament. **Registration is not retroactive to tournaments already completed or started.**
- **SWT membership does not guarantee spots in any or all tournaments.** Members must register at each tournament at the earliest possible date to insure participation.
- Members are **not** required to fish all five tournaments in the circuit. The SWT also accepts entries from non-anglers.
- **Must be a SWT member to receive any SWT prizes**

SWT 2007 Rules & Regulations

Scoring & Point Accumulation

- Scoring will be based on each tournament team score with results being obtained directly from tournament organizers.
- Trail standings are derived from the accumulation of points received from each tournament
- Big Fish must be deemed live and releasable
- Final scoring will be based on the best 4 out of 5 qualifying scores of each tournament, except for the overall 1, 2, and 3 tournament categories, Dooly's High Five, or Backwoods High Five
- In case of ties, the tie breaker will be the highest finish in any tournament. If still tied, the second highest finish of the year and so on until a winner is declared. If still tied at this point the award will be shared. Decisions on judgement calls by the SWT will be final with no appeal
- All members are to present themselves in a professional manner. Any grievances are to be brought to the SWT Board of Director's to be dealt with.
- The SWT makes every effort to be accurate with Stats. However if there is any discrepancy, you must inform the SWT of the mistake within a reasonable time and if an error is found, it will be corrected.
- For what ever reason that a sponsors prize is no longer available it is not the SWT's responsibility to replace with cash value or other prizes. The prize category will be eliminated
- In all cases the spirit of the rules will prevail
