Final Tournament of the Saskatchewan Walleye Trail

The organizers will be having a tournament within a tournament at the 2010 Fall Classic.

Anglers that wish to be involved will pay an additional \$400.00 and the payout will be divided to the top 3 finishing teams that are involved, 1st place = 50%, 2nd place = 30% and 3rd place = 20%, the organizers will retain an administration fee. Registration for this can be mailed in with entry, those waiting until registration night, it will be cash only, accepted.

Official Rules 2010 LAST MOUNTAIN FALL WALLEYE CLASSIC

1. Eligibility

A) All persons 16 years of age or older are eligible to enter the Walleye Classic Tournament. Anglers under 16 must fish with a parent or guardian.

2. Requirements

- A) Each contestant must have in their possession a valid Saskatchewan fishing license.
- B) Promoters and organizations assisting in the tournament operation, their agencies, and agents, are not responsible for death, injury, damage, liability, theft, fire or any loss to any entrants. Each entrant, upon signing an accepted entry form, will in effect be signing a waiver form.
- C) Each entrant will be required to have a US Coast Guard or Canadian approved personal flotation device (PFD).
- D) Each entrant **must wear a PFD** when moving, other than trolling.
- E) All contestants are required to observe Canadian Rules and regulations concerning safe boating.
- F) One team member **must attend** the rules meeting.

3. Fishing

- A) Only Walleye will be included in official totals.
- B) Only those fish caught on hook and line in a legal manner will be accepted.
- C) Each fisherperson is allowed one (1) line in the water at a time. Spare rods and equipment may be carried in the boat.
- D) Live bait, artificial bait and lures are allowed. Electronic or any electric luring attracting devices are prohibited. **NO LIVE MINNOWS.**
- E) Any Walleye mangled, mashed or mauled will be weighed and credited at the discretion of the officials.
- F) Entrants will conduct themselves as true sportspersons when fishing near another boat. There is no restricted area around another boat, however no boat may touch another boat. No interference with another angler's line will be allowed.
- G) A contestant must **NOT** leave the boat to land fish, untangle lines or lures.
- H) **The 2010 tournament daily limits will be 5 fish per team per day; 3 fish under 21.5" and 2 fish over 21.5" or all fish under 21.5".**
- I) All contestants are required to keep fish alive by means of live well tub or other means. No more than 5 fish will be permitted in the live well at a time. Once a fish has been weighted and recorded, no substitutions will be allowed- this rule applies to slot size fish and large fish. Any fish not able to be live released will be **penalized 20%** of the weight of the dead fish.
- J) Stringers and ropes may not be used to confine fish caught.
- K) **No fishing in the Fish Release Area.**

4. Boats and Equipment

- A) All boats will be required to meet Canadian regulations.
- B) All boats will be required to carry a provincial or state registration in accordance with the regulations of the home province or state of the contestant owning the boat.
- C) Boats may be equipped with electronic positioning or trolling motors.
- D) Electronic and electrical depth finders, thermometers, oxygen meters etc. are allowed. **NO UNDERWATER CAMERAS.**
- E) **No communications Devices** such as cell phones, pagers, two way radios, marine band radios binoculars, etc. are allowed on the boat.

5. Tournament Boundaries

A) Fishing will be permitted in the part of Last Mountain Lake identified on the map to be provided on acceptance of registration.

6. Weigh In

- A) The scale for weigh in will be open through out the fishing day starting at 10:00 am each day.
- B) Each team will be responsible for their own catch. Under no circumstances may anyone other than the contestants handle or touch a fish until after it has been presented for weigh in.
- C) A team member must accompany the fish to the scales. Each team will receive a copy of their scale ticket each time they weigh in fish. A team member must initial the scale ticket at this time.
- D) An unloading area will be designed immediately in front of the marina entrance and will be for unloading of fish only. No fishing allowed in this area.

7. Fish Measurement

A) All fish will be measured with the tail pinched, **check both sides.**

8. Fishing Hours and Starting

- A) Start, finish and flight times will be provided at the pre-tournament meeting. In case of a storm, the tournament will be a one-day event. (At the discretion of Tournament Committee)
- B) Contestants who return late will have all the fish in their possessions at the time disqualified.
- C) Boats will leave in flights accompanied by a pace boat. The flights will be alternated each day.

9. Boat Identification and patrolling.

- A) All contestants' boats will be identified with a numbered decal. A team number will be assigned when notified of acceptance into the tournament. Decals will be provided at rules meeting. **Place decal on left side of boat.**
- B) If an emergency occurs, patrol boats will be available for aid. Patrol boat personnel will be clearly marked for easy identification. All contestants' boats are allowed to dock at headquarters only.
- C) Boats may be inspected before and during the tournament. Tournament officials will be checking boats at the launch area. Patrol boats will be intensively patrolling the fishing areas. Any cheating of any sort will result in immediate disqualification, if protests are upheld.

10. Prize

- A) Prizes will be based on most weight (pounds) caught during the tournament.
- B) A prize for the largest live Walleye will be announced for each day.
- C) Prizes will be awarded on a team basis.
- D) In the case of a tie, prize money will be pooled and divided equally among the teams involved.
- E) Any angler found to be cheating will be disqualified and prosecuted to the extent permitted by law.
- F) **All prizes are based on a 110 team field.** Tournament Organizers reserve the right to increase entries. Additional monies will go towards the current prize structure. Final prize structure will be announced at the rules meeting.
- G) Teams **must be entered** in Big Fish category prior to the start of the tournament to be eligible.

11. Spirit of the Rule

A) All rules have loopholes. It is the intention of the sponsor to provide an honest, sportsman like tournament. In the interest of good sportsmanship, contestants are reminded of the spirit of the rule will prevail in all judgments.

12. Protests

- A) Any contestant has the right to make a protest against another contestant. A protest form is available from the tournament chairman and filled out, and presented to the chairman within one hour of close of the fishing day.
- B) A special protest committee will convene for the purpose of determining action. Both parties and possible witnesses may be called before the committee. The committee will meet within three (3) hours of any protest being formally presented.
- C) a \$150.00 protest fee will be required to accompany any formal protest. The fee is to be returned if the protest is found valid by the protest committee. If invalid, the fee will not be refunded. The decision of the protest committee is final in all cases.

13. Miscellaneous

- A) All questions or problems relating to the rules of this tournament are to refer to the tournament committee. Their decision will be final in all cases. No other person can be considered a spokesman for the rules during the tournament.
- B) If one of the two-team members drops out before the tournament, they may be replaced by the choice of the remaining team member. The chairman **MUST** be notified of the change **BEFORE** the tournament. **NO** substitutions allowed after the tournament has started.
- C) If an entire team drops out before the tournament, the place will be filled by the tournament chairman and not the choice of the team that drops out. Entry will be refunded **ONLY** if notice is given **at least 14 days prior** to the start of the tournament. **NO EXCEPTIONS.**
- D) A \$30.00 fee will be charged on any approved cancellations.
